

## **In Case of Bad Weather**

If conditions are better for **Surfing** than **Paddleboarding**, the daily activities will be surfing lessons and practice.

In the unlikely event of bad weather, that prevents the attendees from practicing any activity between SUP Tours, SURF, SUP Wave or SUP Ball, a list of alternative activities will be purposed at the moment, with a choice between: Bike Tours, Hiking Tours, Bird Watching Tours, Van Tours, Guided walks around the island and of its attractions.

## **Restaurant discounted prices and fares**

Dinners for not included nights are suggested in the hotel's restaurant, only place that serves dinner before 8.00 pm, and that can make vegetarian and vegan options.

The cost is 25 euros per dinner and includes 2 courses and water.

If you wish to go to a restaurant in town, the hotel shuttle can take you there and pick you up t an agreed time.

- 7) In the unlikely event that we are not able to supply the services for reasons of our responsibility<sup>1</sup> the Italian law Art. 1385 Italian Civil Code permits a refund of: 100% of the deposit A % of the full payment depending on the reasons of the services supply impossibility With a maximum of 200% refund of the deposit in case of mere power of Sup Adventures.

8) Whilst it is extremely unlikely that changes will need to be made to this holiday, Sup Adventures and Pure Paddle Fitness reserves the right to do so at any time. We shall inform you if this is necessary.

In the event of a dispute with other subjects we will give you reasonable help to solve the matters.

Cancellation up to 1 month before the start of the Retreat: 50% refund.
